¹ Doctors` certificates are accepted for sickness of no more than 7 days during the thesis writing period. If the duration of the sickness is longer, a sickness certificate from the public health officer in charge of HTW has to be submitted (ask MIDE Office for the address).

Thesis – application, admission, writing etc.

- Students must apply to be admitted to writing the final paper (thesis) using an **application** form. Deadline for application is the end of the lectures of the winter term (summer term if students postpone writing the thesis by one semester). However, the earliest date for the official application is 8 January 2024. After application, it will take until April for the exam committee to grant admission in written form. In the application form, please propose your topic and the 1st supervisor. The 1st supervisor has to approve your topic proposal by Email (topic and semester of thesis writing period should be mentioned). The 2nd supervisor will be appointed by the exam committee, but you can make a proposal. Note that the wording of the topic cannot be changed once you are admitted to the thesis writing period. You may choose a subtitle later on, though.
- 2. After having applied via <u>Moodle</u>, you will receive an official **approval letter** from the examination committee in case all necessary documents have been submitted, you have reported back for the semester and your topic is approved. In this approval letter you will be informed about the official starting date for the writing period. The admission form will be sent to you in the week before the official start of your thesis writing period.
- 3. The **normal writing period** starts on the dates mentioned. A later start of writing can be accepted in the case of an internship. Oral exams are scheduled individually, normally around 4 weeks after submission of the final paper. The max. length of the thesis is 12,000 words, minimum is 10,000. This excludes the cover page, table of contents, list of tables/graphs, bibliography and appendices. If you write more than 12,000 words, your grade can be reduced. After your successful oral exam, students lose their student status at HTW Berlin.
- 4. If students want only for urgent individual reasons to start their thesis work earlier, please indicate on the application form your preferred dates. This is only possible when (1) all required modules have been passed (5 ECTS may be pending) and (2) there are urgent individual reasons put forward to the exam committee in writing.
- 5. The oral exam can only be scheduled if you have successfully finished **all** MIDE courses (and gained all additional ECTS, if applicable).
- 6. You have to submit your thesis in **due time** according to the time limit indicated in the admission letter that you receive from the exam committee. Late delivery is counted as a fail. This regulation is strict.
- 7. The processing period of **13 weeks** for writing the thesis can be **prolonged by max. 4 weeks** if you apply in writing to the chairperson of the exam committee (Professor Joebges) with an explanation. This application must be written in due time *before* the expiration of the 13 weeks and as soon as you are aware of the impediments. Such exceptions are confined to unforeseeable difficulties like non-availability of literature or data or impediments caused by third persons or institutions. Periods of sickness are exempted from the 13 weeks limit if proven by a medical certificate. The final decision about this application is made by the chairperson of the exam committee. Note that a prolongation of the thesis work will cause a postponement of the oral exam.
- 8. If you start work on your thesis and come to the view the topic is, after all, not suitable, you may apply to the exam committee to **change the topic of your thesis.** The change must occur within the first 6 weeks after the commencement of the thesis, there can only be **one** change. Such an application must be accompanied by a proposal for a new topic not related to the old one.
- 9. The thesis is evaluated by the two supervisors and accounts for 40% of the final grade of the master programme. The scheme for thesis-evaluations as recommended by the exam committee can be found at the end of this document. The oral exam which focuses on the theme of the thesis counts with 10%. A "fail" in the oral exam leads to failure of the final exam. The oral exam can be repeated once.

- 10. If the thesis is evaluated with "fail", students have to start a new thesis with another topic immediately. If this leads to "fail", there will be no further opportunity to get the master's degree.
- An abstract of the thesis (max. 20 lines) plus information about the word count should be included. The Ecopy of the thesis must be uploaded for a plagiarism check (<u>Guidelines to</u> <u>formulate a Master Thesis Proposal</u>).
- 12. The thesis must be written entirely in your own words. If you wish to make a point by using the words of another author, this must be shown in quotation marks with the source of the quotation clearly indicated. In the event of any **plagiarism**, the thesis will automatically be marked as a "fail". If you use other authors' ideas, this has to be indicated by reference in the text and in the bibliography. The thesis will be checked by the software "OURIGINAL" for plagiarism.

13. The most frequent shortcomings of master theses are

1 unclear or too broad research questions

2 only summarizing literature on the topic without authentic contribution of the author 3 incoherent outline/structure

4 insufficient knowledge on academic literature related to the topic

5 poor command of English language, hence imprecise writing (you may ask/hire a native speaker for final proofreading)

- 6 poor time management
- 7 formal shortcomings in referencing and bibliography
- 8 writing abroad without effective supervision by the 1st supervisor

Evaluation of Master's thesis by supervisors – recommended criteria (MIDE)

- 1. Formulation of clear and adequate research questions
- 2. Structure of the paper
- 3. Literature: Range, sources, quality, adequacy Presentation of appropriate economic theory
- 4. Research and analysis
- 5. Integration of theoretical and empirical analysis
- 6. Creativity & originality
- 7. Compliance with formal rules: references, citation, language, formatting
